

Village of Pewaukee Police Commission

Meeting Minutes

November 3, 2025

I. Call to Order/Roll Call

President David L. Spakowicz called the meeting of the Village of Pewaukee Police Commission to order at 1:08 p.m. on November 3, 2025. Secretary Peter Rohde was excused from the meeting; Therefore, President Spakowicz conducted a roll call. The following persons were present: President Spakowicz, Commissioner Jodie Borckmann and Commissioner Jeffery Bublitz. As stated, Secretary Rohde was excused. As was Commissioner William Gehrking. Chief Timothy Heier and Deputy Chief Brian Foth were also present. President Spakowicz stated that he had advised Commissioner Gehrking that the commission could arrange to have Commissioner Gehrking participate in the meeting via a Zoom call. Commissioner Gehrking denied the opportunity to participate.

II. Citizen Comments

There were no citizens present at the meeting. President Spakowicz asked Chief Heier if he or the department had received any communication from anyone with information that required the attention of the police commission? Chief Heier stated that he nor the department had received any communication or concerns from any citizen(s) that was appropriate for the police commission to address.

III. Approval of Minutes of Previous Meeting

The minutes of October 6, 2025, meeting had been previously sent out to members of the commission by Secretary Rohde. After review by the commission, Commissioner Borckmann made a motion to accept the minutes as presented. Commissioner Bublitz seconded the motion. The motion passed unanimously.

IV. Closed Session

Commissioner Bublitz made a motion that the Police Commission move into closed session pursuant to Wisconsin Statutes Section 19.85(1) (c) to consider employment, promotion, compensation, or performance evaluation data of any public employee over which the governmental body had jurisdiction or exercises responsibility – specifically regarding Police Sergeant candidates. The motion was seconded by Commissioner Borckmann. A roll call vote was taken by President Spakowicz. The motion passed unanimously. The commission moved into closed session at 1:12 p.m.

V. Reconvene into Open Session

Commissioner Bublitz made a motion to reconvene into open session. Commissioner Brockmann seconded the motion. President Spakowicz took a roll call vote and the motion passed unanimously. The Commission reconvened into open session at 1:50 p.m.

VI. Possible Action on Police Sergeant Candidate

A motion was made by Commissioner Borckmann to recommend the name of Michael Duncan be forwarded to Chief Heier for promotion to the position of Sergeant of Police. The motion was seconded by Commissioner Bublitz. The Motion passed unanimously.

VII. Adjournment

Commissioner Bublitz made a motion to adjourn. The motion was seconded by Commissioner Borckmann. The motion was passed unanimously. President Spakowicz adjourned the meeting at 1:58 p.m.
