



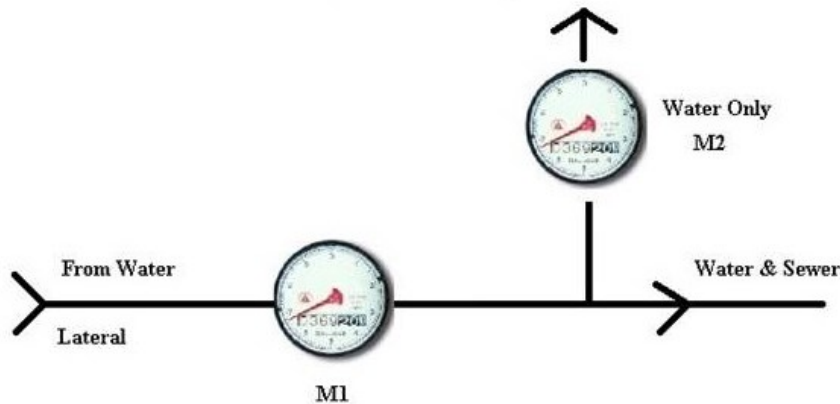
SEWER DEDUCT METER REQUEST CHECKLIST

1. ___ Review quarterly service charges and gallons per quarter/year to breakeven. The breakeven amount only includes the usage of water going through the sewer deduct meter. If you do not use 5,000+ gallons per quarter for a sprinkler system, filling a pool, watering your lawn, washing your vehicles, etc. then this may not be beneficial to you.

2. ___ Apply for a plumbing permit through Building Services at the City of Pewaukee (262) 691-9107 or visit their website at www.cityofpewaukee.us.

3. ___ Have the appropriate plumbing work completed following the allowable configuration for deduct meters.

4. ___ Schedule final inspection of plumbing work with the City of Pewaukee Building Department, contact information above.

5. ___ Fill out and return the *Sewer Deduct Meter Request form* along with a copy of the *permit and proof of passed inspection* to the Village of Pewaukee either by email to Kayla at khaack@villageofpewaukeewi.gov or mailing it to Village of Pewaukee Utility, Attn: Sewer Deduct, 235 Hickory St, Pewaukee, WI 53072.

6. ___ Once all applicable information is received, someone from the Village will contact you to schedule your sewer deduct meter install.

_____ I understand I am responsible for the quarterly sewer deduct service charge applicable to my meter size.

_____ I understand this meter does not exempt me from paying for water used, rather it reduces the # of gallons charged for sewer.

_____ I understand this is not a seasonal meter and will not be removed/reinstalled seasonally. This is a year-round quarterly charge.

_____ I understand, should I no longer wish to have a sewer deduct meter in the future, a request for removal can be made, but the residence will not qualify for a sewer deduct meter for one full calendar year after removal. (ie. cancel is August 2023, eligible January 2025)
